

ASE Feed & Supply Job Description

WAREHOUSE/MILL/DELIVERY ASSOCIATE (Full time)

QUALIFICATIONS

Minimum age of 18.

Friendly attitude and good work ethic.

Reliable transportation.

Lift 80 pounds at a time.

Valid driver's license; No more than 1 moving violation per year in the past 3 years/more than 1 accident in past 3 years.

Previous warehouse experience (not mandatory but preferred).

Organization skills.

DRESS CODE

Employees are permitted to wear work-place appropriate jeans/shorts and t-shirts free of holes. Unsoiled shoes are required, and hats are allowed.

ATTENDANCE POLICY

Arrive each day at your scheduled time.

2 weeks of paid vacation is permitted yearly* Submit time off requests to Stacy or Ken.

3 days paid time off (sick days/not scheduled) are permitted yearly.*

Call in advance of an unscheduled absence.

After 2 days of absence a doctor's note is required.

Medical insurance is available after 60 days of employment (full time employees).

One year of employment is required for paid vacation/sick leave (full time employees)

DUTIES

Timely and efficient delivery and pick-up of bagged products, complete appropriate logs.

Warehouse duties:

Assisting customers with loading product

Bagged ingredient receiving and storage

Restocking retail space

Preparing orders for bag delivery

Sweeping/cleaning warehouse as needed

Assist in mill operations including bagged ingredient receiving and storage, blending rations, proper medication use, packaging product, and re-working feed when necessary.

Report to Ken or Stacy.

Know Emergency Action Assignment.

Follow personal and animal food hygienic practices while performing all job duties.

COMPENSATION

The Warehouse Associate will be paid \$12-15 hourly based on education and experience, and will receive their paycheck every two weeks. Direct deposit is available upon request.

BENEFITS

ASE employees that work over 25 hours weekly are eligible for health insurance through Anthem Blue Cross & Blue Shield. Aflac is also offered on a voluntary basis. A simple IRA is available with a 3 percent match after 90 days of employment.
